REGISTRATION PROCESS:

You will be required to complete two (2) registration forms, Louisiana Youth Karate and Unity Day Youth. You can complete the Louisiana Youth Karate registration form (*found online*) in advance and submit it at your first session. The Unity Day Youth registration form must be completed at your first session. All forms must be completed by Parent or Legal Guardian.

Maximum 25 Student-Athletes per Group Training (*Initially*)

In order to receive either option, the Student-Athlete will be evaluated based on commitment to the Louisiana Youth Karate program, participation in Louisiana Academy's academic activities, and loyalty to the Louisiana Youth Sports Network programs.*

I certify that the Student Athlete is in excellent physical health, and may participate in strenuous and hazardous physical activities, including the Karate to be played in the Program. Permission is granted for the Student Athlete to receive emergency medical treatment, if needed. I also agree to indemnify and hold harmless those listed above for all claims arising out of the Student Athlete's participation in the Program and all related activities. I agree to let the parties use the Student Athlete's name and likeness free of charge in any manner and for any purpose without compensation to the Student Athlete or me. I understand that this document is intended to be as broad and inclusive as permitted by the laws of the state of Louisiana and agree that if any portion of this Agreement is invalid, the remainder will continue in full legal force and effect. I am the parent or legal guardian of the Student Athlete. I am of legal age and am freely signing this Agreement. I have read this form and understand that by signing this form, I am giving up legal rights and remedies.

1. The risk of injury to Student Athlete from the activities involved in these programs is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for Student Athlete's participation; and,
3. I willingly agree to comply with the program's stated and customary terms and conditions for participation; and,
4.
